Spay-Neuter Services of Indiana (SNSI) and veterinary clinics in Indiana have agreed to spay or neuter your pet for a reduced cost for the month of February. Select a participating veterinarian below and schedule your appointment directly with the clinic. Be sure to tell them you are using this special spay/neuter certificate. When calling for an appointment, please ask the clinic if there are any other required services for which you will be charged. You must complete this certificate and present it to the clinic at the time of the surgery.
