Spay-Neuter Services of Indiana (SNSI) and veterinary clinics in Indiana have agreed to spay or neuter your pet for a reduced cost for the month of February. Select a participating veterinarian and schedule your appointment directly with the clinic. Be sure to tell them you are using this special spay/neuter certificate. When calling for an appointment, please ask the clinic if there are any other required services for which you will be charged. You must complete this certificate and present it to the clinic at the time of the surgery.

**Please see page two to select your vet and complete the form to leave with your vet. Veterinarians' calendars fill up fast, so please call as soon as possible.**

This certificate is valid to have one cat or dog spayed/neutered. The reduced fee includes all costs (office call, anesthesia, pre- and post-op care) related to the surgery. You are responsible for paying the clinic the reduced fee for your surgery, vaccinations (if needed), and any additional charges for services required by the clinic or chosen by you at the time of surgery. **The certificate is only valid for appointments made for the month of February.**
